## SDGE Fire Costs Rate Hike Meeting

In case you have not heard, once again SDG&E wants to pass on costs of the 2007 wildfires to customers. The California Utilities Commission will hear public comment on SDG&E's bid for a rate hike on January 9th at the California Centre for the Arts in Escondido. Two meetings will be held: one

at 2:00 pm and one at 7:00 pm.
